BACKGROUND

During 2018-2019, the Lillooet Area Library Association explored the idea of a Social Enterprise with the community through research and workshops. Following this work, ideas have been discussed and constructed over the last year with many non-profit organizations. Funding through the Vancouver Foundation Investment Readiness Program will allow us to explore this new social enterprise business idea, test for feasibility, understand what will work and what may not, and then develop a business plan and marketing materials to take the idea to the next level — to approach potential investors. We believe this is an excellent opportunity to hire a consultant familiar with social enterprise development to help move these ideas forward, and to build capacity in our community around innovative project development, facilitation and communication. It is important to us that any contractor working on this project includes local volunteers, staff and contractors in the process so that knowledge is transferrable, thereby enabling us to facilitate and grow other innovative projects in our region in the future.

Lillooet Area Community CONNECT Hub – Is it feasible? What is feasible?

The Community CONNECT Hub could provide the space, the staffing and programs to support multiple sectors of our community. We envisage a collaborative space with the following components that work hand-in-hand to provide a social good while generating income to ensure self-sufficiency:

- Apprenticeship/Mentorship Training Program to support at-risk, unemployed or underemployed people, while learning skills in all aspects of the agriculture, art/craft, food service and small business industries. A unique hands-on learning environment that gives participants the skills to go out into the workforce and/or to start their own businesses. A place, also, where potential workers can be on-call to provide service to local farmers, and small businesses as needed, again learning while doing.
- "Storefront" professional art and natural history gallery, local food coop, local art/craft sales, tourism bookings, reuse it store.
- Farmers Cooperative farm-work, delivery, processing, sales at "storefront" and within community (done by apprentices under the direction of trained staff thereby supporting farmers)
- **Art Cooperative** space for artists to work, be paid to train apprentices, showcase their skills to the public and sell products in the "storefront" (artist-in-residence programs)
- Chamber of Commerce office and small business incubator
- Lillooet Volunteer/Community Connect office
- Event Café and Collaboration Space— used for Community Conversations, meetings, workshops, etc
- Co-working Space workspaces, meeting rooms, call booths, supports
- MakerSpace community space to explore STEAM projects
- Communication Centre newsletters, social media, podcasts, filming, radio
- Stand-alone facility or possible exploration of ground floor of new housing complex

Each component of the Hub will have a way to generate income from the sale of goods and services, and through rental and/or registration fees. Membership in the Hub will also be offered to community members and partners in the project. The Hub will bring together St'at'imc and settler communities to work on innovative projects together by ensuring the space has strong representation from all communities, is inclusive, respectful and exciting. The Hub is situated on the traditional and unceded Territory of the Northern St'at'imc Nations. Our hope is to put Truth and Reconciliation into action in Lillooet.

FRONT OF HUB:

- Art and Natural History Gallery (high quality museum-type gallery showcasing local art and local natural history
- Community HUB Store produce, art/craft goods and supplies, place to book tourist opportunities
- Reuse It Store good quality unique 2nd hand items

HEART OF HUB: Also open to public

- Farmers Coop (Commercial Kitchen) delivery area, processing of foods (drying, canning, etc), packaging for sale, sale in store and delivery program (staff/farmers mentor apprentices in all aspects of agriculture including work on farm days and pop-up cafes on farms)
- Artist Coop work space for artists to make wares where public can also watch, train apprentices, and host workshops (possible partners: Emily Carr; Kootenay School of the Arts)
- Chamber of Commerce Office/Business Incubator
